Legislative Committee

Last week on May 4th, the Republican controlled House of Representatives narrowly passed an amended version of their repeal and replace bill, the AHCA. Now this will go to the Senate and we still have a long way to go before any legislation can be enacted and actually become law.

A long way to go is an understatement! Like the various Republican factions in the House, the Republicans in the Senate are not in complete agreement how to best do this either and will probably not vote for this bill the House just passed, but come up with their own version of how this should be done. This will not be easy as the Republicans hold a slim 52-48 majority of the Senate, so if more than two Republican Senators defect, nothing gets passed as it is unlikely any Democrats in the Senate will vote to support this. If the Senate does get a bill passed, then both bills go to a House/Senate joint conference committee where they will attempt to hammer out a compromise bill that will have to go back to both houses of the Congress to vote to pass before it can go to the President to sign into law. This is also only the very first phase as this bill only deals with revenue/budgetary parts of the ACA under the reconciliation process that requires a simple majority to pass. Non-reconciliation legislation requiring 60 votes in the Senate (all Republicans and 8 Democrats, or some combination equaling 60) will be required to repeal/replace the non-revenue/budgetary parts of the ACA, which is a much bigger hill for the Congress to climb.

As this goes through the legislative process, NAHU will be keeping us updated through their legislative e-mails and their Washington Updates. If it becomes necessary, Operation Shouts may come out that will require urgent action by NAHU members to respond, so please be aware of these and respond to our Members of Congress with your opinion when requested.

HUPAC Chapter Challenge and Updates

The HUPAC Chapter Challenge is back... but with a twist. Starting with contributions from March 1 to June 1, HUPAC will recognize those chapters that increase the number of members who are contributing to HUPAC by two percent. For example, if your chapter has 50 members and 10 of them are contributing, that puts you at 20% of your chapter contributing. Your chapter would need to

increase that by two percent, which would mean you need to recruit just one more member to contribute. Simple, right? The goal is to increase the involvement of members in HUPAC.
